Community Health-Related Causes • Volunteer Fire, Ambulance and Rescue, Cancer Society, Juvenile Diabetes programs, YMCA, Food and Shelter Programs, Local Area Hospital, Nursing Centers and Outpatient Clinic support, Recovery programs, and Health and Fun Runs.

Health and Welfare of Community Children • Girl and Boy Scouting programs, Boy and Girl PAL/Youth League Programs, Pee Wee Sport Programs, Fair and Livestock Programs, Coloring Contests, High School Athletic Programs.
